1. Report on Treasury

Sue Kinzie presented treasurer's report dated 12/27/2012, provided each member with report copy.

2. Report on Krispy Kreme fundraising

Sue Kinzie presented report on Krispy Kreme donut fundraising cards. 8 cards sold, 12 remaining to sell.

4. Amend By-Laws

Changes-only approved by all board members. Final bylaws need to be reviewed and presented at next board meeting for possible board approval.



5. Design Logo

Organization logo variations reviewed. Logo created around 2009 (shows horse, person, dog, cat heads) approved by all board members. Logo will be used in the header of all Pathways documentation (e.g. meeting minutes).

6. Design Brochure

Brochure has not be revised in several years. Need to revise with specific details such as purpose of Pathways funds, goals, phases for specific tasks.
