7. MISSION STATEMENT

Revised based on member email comments and also on meeting comments by Sue, Raymond, David. Sue wants to use this as part of the Pathways brochure. David recommended keeping the statement simple and list specific tasks.

Sue wants to know cost comparisons for 8.5"x11" folded versus card 1/2 page card stock, color versus black-white, mailing cost.

Sue recommends brochure includes testimonials, goals, use the brochure for fund raising as incentive for people donating money.

Raymond thinks brochures are a waste of money, should try to use electronic media such as email and Facebook.

David suggests emailing brochure to people as a nicely formatted PDF document. Include statistics in the brochure so people will see that Pathways has done something (e.g. money amount distributed to animal rescue groups, number of animal transports).
