12. TRANSPORT PET FIRST AID KIT AND TRANSPORT VEHICLE RESCUE TOOLKIT DISCUSSION

Raymond comments:	Key supplies are bandages, homeopathic medicines for vomiting, water dish and jug, emergency food (avoid feeding if possible)
David comments:	Goal should be to protect animals, transport people and vehicle, rescue toolkit thinks also important (includes hammer, rope, bolt cutter, collars, leashes)
Sue comments:	Muzzles for different size dogs, leashes and collars

TO DO - DAVID Create draft transport first aid kit and vehicle rescue toolkit guidelines

13. TRANSPORT ANIMAL CRATE PURCHASING DISCUSSION AND APPROVAL

Sue would like Pathways to buy 2 small/medium animal crates for transporting since currently borrows crates from Desert Paws. Pathways currently has 1 small crate, 2 extra-large crates, 1 cat crate. Will wait to buy crates until after seeing what crates others may donate.

Cookie said she would donate a crate (size unknown).

David recommend 2 medium dog crates, thinks a good Pathways investment.
